## UC SAREP's current agritourism work

### Help plan "Agritourism Intensive" classes in Mendocino & SLO Co.?



With funding from Western Extension Risk Management Education, UC SAREP will work with local agriculture, tourism, community and agritourism organizations in Mendocino and San Luis Obispo Counties to plan "Agritourism Intensive" classes for farmers and ranchers, with classes to be offered in Winter 2020-21.

For years, Agritourism Intensive has meant three full-day learning and networking sessions in each region, including small-group sharing, eating lunch together and learning from local experienced agritourism operators, county planning staff and local tourism, business and marketing experts in person. This year may be different.

We will plan together what format will work best for each region, whether it is online, in person, or a mix.

We invite anyone involved in agritourism in Mendocino or SLO County to join us as advisors in this planning venture. We may meet in person to plan, or we may start with zoom meetings. 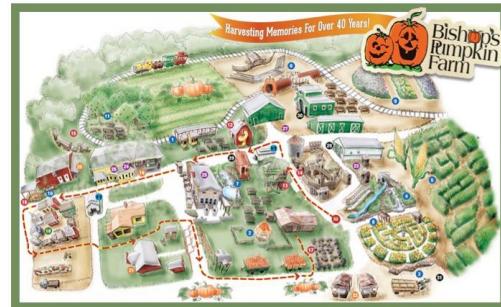
## Planning for Fall? - updates from around CA

**From Wayne Bishop, Bishop's Pumpkin Farm, Wheatland, Yuba County:**

It's a different kind of year isn't it?

Our fall agritourism season provides the bulk of our annual income, so we are very anxious about how it will turn out. We do feel fortunate to be in Yuba County, where there has been a low rate of infection and where our local government has taken a leadership role in getting businesses opened up. **From Karen Macedo, RAM Farms Pumpkin Patch and Corn Maze, Turlock, Stanislaus County:**

We are moving forward, planting pumpkins in the same amount as last year. We're also planting our 20-acre corn maze. Most years we get up to 1000 people in the maze on Friday and Saturday evenings. This year... [read more](#)

Tanaka Farms, I am embarrassed to say, is doing well. Even though our farm tours and U-pick was shut down for two and a half months, our drive thru produce stand and CSA has made up the difference. **From Deborah Munch, David & Sharon Osteen, Clayton Valley Pumpkin Farm, Contra Costa County:**

It has been a hard decision, but we have decided to call off all our field trips this year and not open to the public at all this fall. We would need a lot of visitors to make our normal operations... [read more](#)

**From Phil McGrath, McGrath Family Farm, Camarillo, Ventura County:**

We have had a pumpkin patch for over 40 years, and the last 20 years its been all organic. We will be taking all the precautions necessary... [read more](#)

**From Craig Underwood, Underwood Family Farms, Moorpark & Somis, Ventura County:**

We think it will be a huge crowd this fall, based on the number of people coming to our farm stand and U-Pick patches. The farm stand is still busy, although down a bit from the first rush in March and April. Most days we have 600 to 700 people out picking, with 2000 or more on the weekends. At Murray Family Farms we operate in three sectors; tourism, direct fruit marketing through our two freeway retail facilities/off site farmers markets and wholesale fruit sales through other people's packing houses. ### Farm Aid Launches Farmer Resilience Initiative

Farm Aid has announced that it is distributing \$400,000 to launch a national [COVID-19 Farmer Resilience Initiative](#) in response to COVID-19. As part of the initiative, Farm Aid, with the help of local and regional partners, is distributing grants in \$500 increments to help farmers meet household expenses. In addition to the grants, Farm Aid is providing resources from its national partners, which include Farmers' Legal Action Group (FLAG), Rural Advancement Foundation International-USA (RAFI-USA), Indigenous Food and Agriculture Initiative, Intertribal Agriculture Council, and the National Sustainable Agriculture Coalition. The initiative includes a number of measures designed to support farmers.



### From Travel Oregon: Expanding Eligibility for the Paycheck Protection Program to DMOs

Senators Cruz, Rubio and Scott have officially introduced [S. 3992](#), a bill to expand eligibility for the Paycheck Protection Program (PPP) to DMOs of all statuses who have 300 or fewer employees.

This bill's provisions match [H.R. 6697](#), the "Local Chamber, Tourism, and 501(c)(6) Protection Act of 2020," introduced in the U.S. House of Representatives last month by Reps. Pappas and Fitzpatrick.

Providing economic relief to DMOs is vital for the travel and tourism industry and the broader U.S. economy and has been a top priority for U.S. Travel since the CARES Act first passed.
